

**ORDINANCE NUMBER 09 - 23**

**ORDINANCE AMENDING TITLE XI,  
BUSINESS REGULATIONS, CHAPTER 116,  
ALCOHOLIC BEVERAGES, SECTION 116.05,  
LICENSES, (B) NUMBER OF LICENSES TO BE ISSUED**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the East Dundee Code of Ordinances, Title XI, Business Regulations, Chapter 116, Alcoholic Beverages, Section 116.05, Licenses, (B) Number of Licenses to be Issued be amended.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the East Dundee Code of Ordinance, Title XI, Business Regulations, Chapter 116, Alcoholic Beverages, Section 116.05, Licenses, (B) Number of Licenses to be Issued be amended to reduce the number of licenses permitted in the A classification from four (4) licenses to three (3) licenses.

**Section Two. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
