

ORDINANCE NUMBER 10 - 07

**AN ORDINANCE APPROVING A RENEWAL OF ORDINANCE NO. 08-54 FOR AN ADDITIONAL NINETY DAYS, ALLOWING FOR A TEMPORARY MOTOR VEHICLE DISPLAY AREA ON THE NORTH SIDE OF ROUTE 72, WEST OF COMMONWEALTH DRIVE, EAST DUNDEE, ILLINOIS.**

**WHEREAS**, In September of 2009, the Village Board approved ordinance No. 08-54, which allowed for the placement of a temporary motor vehicle display area on the north side of Route 72 west of Commonwealth Drive; and

**WHEREAS**, In December of 2009 the Village Board approved ordinance No. 09-38, which allowed for a 6 month extension of the permit for calendar year 2010.

**WHEREAS**, the intent for this area was to allow East Dundee car dealers to display motor vehicles in a more prominent and noticeable area; and

**WHEREAS**; since the inception of the display area, it has been used extensively by Miro Motors for the display of motor vehicles; and

**WHEREAS**, authorization for the temporary area expired, and Miro Motors is requesting a ninety (90) day extension of the permit for calendar year 2010.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the provisions of Ordinance 08-54 are herewith expended for an additional ninety (90) days, through May of 2010.

**Section Two. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.

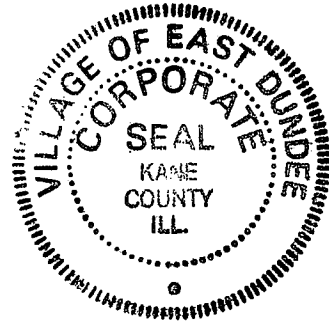
