

ORDINANCE NUMBER 10 - 13

ORDINANCE AMENDING SECTION 53.62 SEWER USER CHARGE OF THE ANNUAL FEE SCHEDULE FOR THE VILLAGE OF EAST DUNDEE

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 9 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the corporate authorities of the Village of East Dundee have determined that the operation, maintenance, and replacement costs of the wastewater treatment facilities in the village exceed the revenue generated by the current sewer user charge; and

WHEREAS, the corporate authorities of the Village of East Dundee have determined that the sewer user charge should result in the distribution of the cost of operation, maintenance and replacement of treatment works in proportion to the users contribution to the total wastewater loading of the treatment works; and

WHEREAS, the corporate authorities of the Village of East Dundee have determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the Annual Fee Schedule be amended to reflect the costs associated with the operation, maintenance and replacement costs attributable to each user.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Annual Fee Schedule of the Village of East Dundee is hereby amended as follows:

CHAPTER 53 – SEWER SERVICE

- 3. Sewer User Charge; (Sec. 53.62 (a)):

Residential and Commercial Rates:
Sewer per 1,000 Gallons \$5.73

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
